



# COMPLETE DRIVING EXPERIENCE ADULT DRIVING LESSON

## CONSENT AND RELEASE OF LIABILITY FORM

1. Driving Lesson Fees: 1 hour - \$100, 3 Hours-\$295,6 Hours-\$595, 9 Hours-\$895, 12 Hours-\$1,195 - Each driving lesson will have a minimum of 45 minutes of practice time.
2. If you wish to cancel a driving lesson, we require at least 24 hours' notice otherwise a cancellation fee of \$50.00 will be assessed. If you do not call to cancel and you do not show up to your scheduled appointment, it will be considered a NO CALL/NO SHOW and will be charged a \$50 fee that must be paid before you can resume driving lessons with CDX.
3. Students will have 90 days to complete driving lessons or exams. There will be no refunds for driving lessons that have not already taken place. If the student has pre-paid for driving lessons, there will be no refunds given in cases of insufficient notice of cancellation (see 2 above)  
Grounds for forfeit of services and account with CDX: Student has lack of communication with CDX placing a hold lesson(s), no scheduled appointments for more than 30-days, no activity in student portal, etc. **IF LESSONS ARE CANCELED BEFORE THEY ARE COMPLETED, REFUNDS WILL NOT BE GIVEN FOR REMAINING LESSONS. NO EXCEPTIONS! NO REFUNDS!** \$100 admin fee upon owners' approval.
4. Students will have a 10-minute grace period to arrive for BTW lessons. If a student is more than 10 minutes late a \$50 NO SHOW fee will be assessed on the student portal. Students are to arrive no more than 10 minutes prior to appointment time.
5. Three accounts of a NO-SHOW your account/lessons will be forfeited with CDX without refunds. If your account holds a balance for more than four weeks CDX has the right to forfeit account and services without refund.
6. Students must provide a valid Washington State Instruction Permit or Driver's License, including foreign driver's license before the first lesson. WA State Law: Mandatory Students carry their valid license/permit during BTW lessons.
7. There can only be a maximum of 4 people in the CDX Driving School Vehicle during the student's lesson time. Example: One Instructor, Student Driver, Instructor(s) in training. CDX will NOT allow any additional person(s) in the vehicle. CDX instructor(s) in training have the right to instruct students on lessons to complete training hours.
8. You hereby release CDX from any liability for damages or injuries resulting from your driving or lack of skills behind the wheel during instruction lessons.
9. While CDX services aim to assist your driving skills they may not guarantee success or roadway readiness.
10. CDX may suggest purchasing additional lessons if they are needed, however not required.
11. CDX has the right to refuse service(s) and/or if we suspect the student is under the influence of alcohol or any substance.
12. If the customer appears to be extremely tired or sleep deprived, emotionally distracted (Upon Instructors evaluations).
13. All cancelled or missed appointments will need to be rescheduled at students' convenience in the student portal. CDX is not responsible for student scheduling.
14. CDX is not responsible for any lost, stolen or damaged items.
15. CDX is not responsible for scheduling or mis-scheduled appointments.
16. CDX does not issue/ mail WA State permits or Licenses.

# COMPLETE DRIVING EXPERIENCE EXAMS POLICY CONSENT AND RELEASE OF LIABILITY FORM

1. The 2025 fees for our CDX Washington State approved Knowledge exam are \$45, the Skills exams are \$85 in the CDX school vehicle. Advanced reservations are required to be made through our CDX website: <https://www.completedrivingexp.com/index.html>.
2. At the start of the Exam, applicants ARE REQUIRED to provide a WDL/Washington ID number, to be eligible to take the knowledge/skills exams and provide proof of identification such as an ID card, photo permit, passport, or passport card, out of state license, or school yearbook.
3. All applicants are required to create and/or have access to their online D.O.L. accounts, Licensing eXpress: <https://secure.dol.wa.gov/home/>
4. CDX Washington State approved Knowledge Exam seating is limited to a maximum of 24 students and will be assigned on a first come basis. Please arrive at least 10 minutes prior to Knowledge Exam session/Skills Exam start time; the doors will be locked promptly at the exam start time. You will have 60 minutes to complete the exam. The Knowledge Exam consists of 40 multiple-choice questions on the topic of Washington State traffic safety laws; the minimum passing score is 32 questions correct. The Skills Exam/drive test will test the applicants' ability to drive legally and safely; a minimum score of 80% is required to pass. All applicants are required to demonstrate arm turn signals prior to the beginning of the skills exam.
5. Re-Testing is permitted for an additional fee, scheduling, registering, and paying for a Knowledge and Skills Exam can be completed from our website. <https://Completedrivingexp.com>.
6. Refund Policy: Refunds are not given for missed appointments or failed Exams. You will have a 5-minute grace period for the Skills Exam, if you happen to arrive after your 5-minute grace period or miss the scheduled appointment you will be charged a \$50.00 No-Show/ Late fee/ Forfeited Exam. If you are late for the scheduled appointment time, your Skills will be forfeited and/or a \$50.00 fine will be required to reschedule. Students are to reschedule missed exam within Two weeks to avoid a forfeited or closed services/account. NO REFUNDS, NO EXCEPTIONS!
7. Washington State D.O.L. requires all driving schools Exam results to be entered into the D.O.L. database within 24 hours by staff. Passing the Knowledge and Skills Exam does not guarantee that an applicant will be issued a driver license. The Department of Licensing will determine if an applicant has met all licensing requirements and issue the license. If you are under the age of 18 you must be at least 16 years old, successfully completed a traffic safety education course, have had your permit for at least 6 months and have had 50 hours driving experience with at least 10-night driving hours to apply for your driver's license.
8. If you received a letter from D.O.L. to take an examination or have a physical, mental, visual or any medical issue, you must test at a D.O.L. office. Failure to disclose this information prior to testing will result in your test not being honored at D.O.L. to obtain your license and we will not refund the test fee.
9. The Department of Licensing reserves the right to conduct random re-examinations; applicants refusing to take a Re-examination may have their license revoked.
10. Pursuant to RCW 46.20.720 a driver convicted of an alcohol offense may be required to have an Ignition Interlock Device (IID) to drive. The applicant must take the skills exam in their vehicle using the IID.
